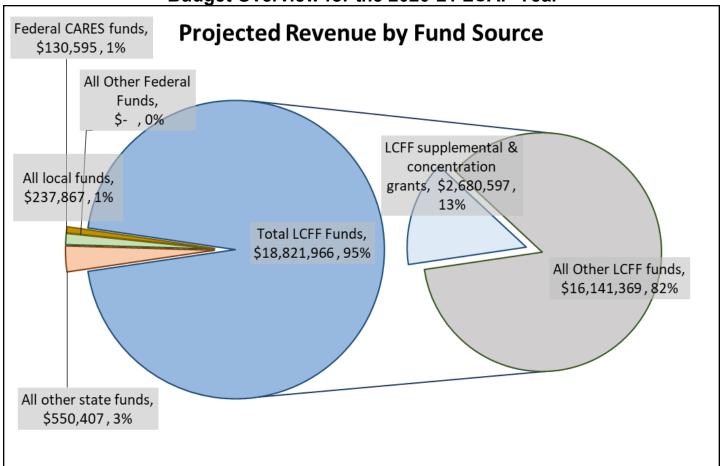

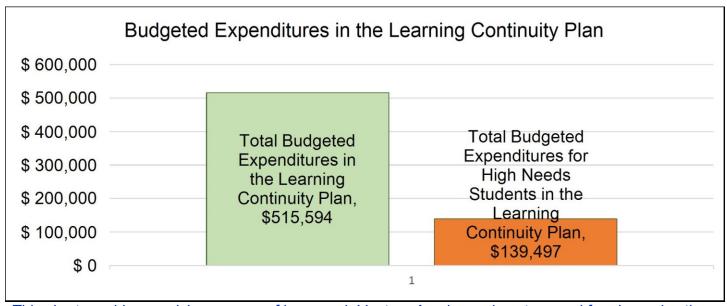


This chart shows the total general purpose revenue Venture Academy expects to receive in the coming year from all sources.

The total revenue projected for Venture Academy is \$19,740,835, of which \$18,821,966 is Local Control Funding Formula (LCFF), \$550,407 is other state funds, \$237,867 is local funds, and \$130,595 is federal funds. Of the \$130,595 in federal funds, \$130,595 are federal CARES Act funds. Of the \$18,821,966 in LCFF Funds, \$2,680,597 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much Venture Academy plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Venture Academy plans to spend \$19,729,461 for the 2020-21 school year. Of that amount, \$515,594 is tied to actions/services in the Learning Continuity Plan and \$19,213,867 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

Other General Fund budget expenditures include those for cost of core services, on-going services for high needs students, overhead, unrestricted lottery & restricted programs such as Lottery and other Grants allocated to the charter.

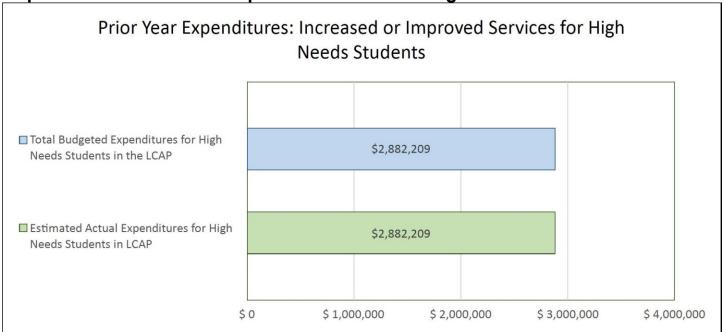
Increased or Improved Services for High Needs Students in the Learning Continuity Plan for the 2020-2021 School Year

In 2020-21, Venture Academy is projecting it will receive \$2,680,597 based on the enrollment of foster youth, English learner, and low-income students. Venture Academy must describe how it intends to increase or improve services for high needs students in the Learning Continuity Plan. Venture Academy plans to spend \$139,497 towards meeting this requirement, as described in the Learning Continuity Plan.

Additional on-going actions/services are targeted toward the specific needs of our unduplicated students and include services to address academic, social emotional and environmental needs that will lead to increase academic achievement.
