We have presented the plan to our community stakeholders, which includes our ASC parent organization, families who speak languages other than English, leadership students, site administrators, special education administrators, SJCOE administrators, and teachers who are members of the local bargaining unit, for discussion and input. We also administered student, staff and parent surveys for feedback in the spring when developing the original Extended Learning Opportunities Grant Plan. This ESSER plan is an extension of the programs developed and implemented in the 2021-2022 school year under the Extended Learning Opportunities Grant Plan. We provided opportunities for feedback over time as we discussed and revised the original Extended Learning Opportunities Grant plan. The original presentation to staff and opportunity for input was in April and May, however, the plan was revisited when the school year started and was amended to address the needs of students and the school based on what we learned from the return of all students to in-person learning, the prevalence of COVID positive cases on campus, and the measured learning and social/emotional needs of students.

The community input mostly focused on the pieces of the plan related to the social emotional needs of students and the extended learning opportunities to be offered. We increased the social and emotional services, including health services, based on community input. We are

also adding an enrichment component to the extended day program for our K-8 students based on community input, rather than a sole focus on learning loss in the extended day.

# **ESSER III Expenditure Plan Instructions**

#### Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
